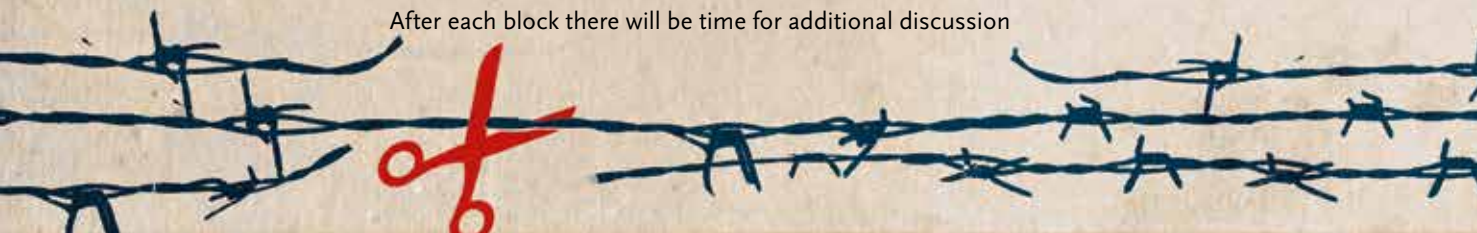

Depletion of refugee's rights: The ministry for interior is planning legal changes in order to further reduce the rights of refugees. The intention is to severely enhance the possibilities of internment of refugees, to undermine family reunification and to implement new entry bans. The so called "welcoming culture" as it is often stressed by politicians, will then for a lot of refugees rather result in deprivation of freedom and imprisonment.

"Safe countries of origin?" On July 3rd 2014 the "Bundestag" (German Parliament) has decided over a draft law that will declare Serbia, Bosnia- Herzegovina and Macedonia as "save countries of origin". This will entail that asylum applications from these countries can be denied as "offensichtlich unbegründet" (obviously reasonless), although Romani people in these countries are often refused access to important societal domains, such as access to work, health services and education and are discriminated against, as refugee rights organizations such as PRO ASYL have assessed. Thus the individual right for asylum is leveraged. Before implementing the law it has to be confirmed by the "Bundesrat" (Upper House).

External EU frontiers: The "deadly" defense against refugees at the external frontiers of the European Union is further expanded. Whoever nevertheless manages to reach the European Union or the Federal State of Germany is forced into a living situation that socially marginalizes and discriminates against refugees and declares innocent people as "criminals". Fleeing is not a crime.

Discrimination: The situation of Refugees still has not changed substantially under the state government of Grüne and SPD: Deportations, placement in "Lagers", prohibition of working and Residenzpflicht determine the live of refugees on a daily basis. In many counties in Baden Württemberg cash payments for the social security benefits of refugees are still refused and

instead food packages and -vouchers are distributed. Indeed the new "Flüchtlingsaufnahmegesetz" (law to regulate the admission of refugees) has changed little for refugees. The draft for revision of the "Asylbewerberleistungsgesetz" (law that governs benefits for refugees, AsylbLG) still allows non-cash benefits, limited health care and restrictions of benefits. The discriminatory law has not been abolished.

Racism: Meanwhile the government and the media are still promoting cheap propaganda against "pseudo-asylum-seekers" and "poverty-immigrants". Fortunately the solidarity with refugees is increasing.

Self-Organization: In the last years refugees have increasingly organized protest against the above mentioned conditions of inhumanity by initiating info booths, squattings, protest marches and demonstrations. In Baden Württemberg there have been corresponding activities of protest in different cities. The actions were mainly focused on exhibiting the inhuman living conditions in refugee homes and lagers, the disenfranchised life situations, the patronizing and control mechanisms, the bullying behavior by officials at foreigner's registration offices and by managers of refugee homes, the custom of deportations and enforced appearances at embassies/consulates of countries of persecution.

Solidarity: It is not our solely aim to inform about our activities and demands. We also want to discuss about ways of necessary solidarity and about how to reach equal cooperation. Self organization of refugees is important and needs to be supported. Outrage, declarations of solidarity, petitions, offertory and support however are not enough. Whoever claims to fight for a society without exploitation and oppression and calls for grassroots countervailing forces, has to comprehend the fight for refugee's rights as their own political duty and challenge.

Unconditional right of residence
Prohibition of deportation custody and deportations
Global right to freedom of movement
Equal social rights for everyone
Abolition of AsylbLG
Repeal of discriminating special laws
Abolition of the Dublin System

To fight for the implementation of these demands is the duty of all of us.

With this in mind we hope that this conference is a first step in Baden Württemberg to bundle our skills, knowledge and power in order to develop shared political approaches. We hope that antiracist networks will be strengthened by the contribution of additional groups and persons.
